# DID YOU KNOW???

A Note from Keith Moyle  
UPPCO

Thanks for being proactive by making UPPCO aware of the outbreak of the Eastern Spruce Budworm disease. We have seen other areas of the Upper Peninsula effected by similar diseases and/or insects like Beech trees, so we are familiar with this type of concern. One of the most affective approaches we have seen to address these types of issues is for the land owners to harvest the areas of concern before the trees become infected and die. If these trees are in close proximity of our power lines UPPCO will assess each situation for assistance with the Tree Removal, or dropping the powerlines.

For reference, the Dead River area is covered by 3 different UPPCO Line Clearance zones. These zones were last trimmed in 2015/2016, with the next cycle scheduled for 2020-2022. Our line clearance process includes regular trimming cycles that are inline with best utility practices for rural service territory companies. In our line clearance process we do have a Tree Removal Criteria. It is to be proactive with assessment and removal of hazard trees near high voltage power lines. These trees typically are dead, dying, diseased, decayed, or leaning towards the line and are considered, by the Utility, to pose an imminent danger to the continued safe operation of the energized primary conductors.

If customers have specific trees of concern that they think are an imminent hazard to powerlines, have them clearly mark the tree and call UPPCO at 906-449-2013 to make up an order and we can assess the situation.

## 2020 Dr. Bruce Turino Memorial FIREWORKS ON THE BASIN

**History of the Fireworks on the Basin:** In 2011, Dr. Bruce Turino came up with the idea of having a Fireworks Display on the Basin. It was his wish to provide a very safe Fireworks Display attempting to eliminate or curtail illegal launching by neighbors that have in the past actually started a few fires in the forest. Kurt Collins, (DRCI shareholder) is the professional launcher along with his crew. The Fireworks are now in their 10<sup>th</sup> year.

**Future Fireworks Funding:** Since the annual Fireworks event has been such a huge success and with ever larger numbers of folks in attendance, at its July 20th, 2016 meeting the Board passed a motion to approve \$5,000 per year from DRCI for all future firework displays. In addition, on February 11, 2020 a motion was approved to match all shareholder donations dollar for dollar in order to build a bigger display. The 2020 budget will be announced on April 15<sup>th</sup>, 2020. Any donations received after that will go toward the 2021 display.

The Fireworks display takes place by "Turtle Island" across from the "Fingers." The Fireworks are scheduled for Saturday, June 27, 2020, at 10:30 PM. (June 28th if the weather is inclement on the 27th).
